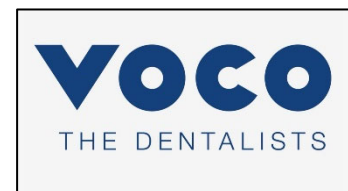

### Are Your Patients Too Sensitive? Discussing, Handling, & Addressing Oral Hypersensitivity / Pain Management with Today's Patients

He has a true passion for preventative and restorative dentistry with an emphasis on biocompatibility and holistic dentistry.

**Course Description:** Is it safe to say if you work in a dental office, you have probably heard a patient complain about hypersensitivity at least once a day? Sensitivity brought about by hot/cold beverages or foods, sweets, or even brushing certain areas of their dentition. Sometimes the patient cannot explain what caused the sensitivity in the first place! Dentists and hygienists tend to treat with typical established procedures which deliver minimal results, or they can offer state-of-the-art formulated products achieving remarkable results.
